The Guernsey Sailing Trust LBG was established in 1988, to enable local children, from all walks of life, to experience and enjoy the fun and challenges involved with sailing, and make the sport accessible to all children. Today, the GST has grown and works closely with the States of Guernsey Education Department and all schools in the Bailiwick. The GST aims to allow every child in the Bailiwick to experience sailing by the time they reach secondary school and welcomes over 2,000 children per annum.

The GST also runs a successful 'Sailability' programme for people of all ages with learning difficulties, physical disabilities and mental health issues. Sailing can offer a sense of freedom that is not felt on land and the sensory nature of sailing also gives many positive benefits to all.

Sailing not only teaches a new sport, but can improve skills such as teamwork, communication, resilience and independence. Studies have shown that physical activity has beneficial effects on health, social and personal development, and mental well being. These positive effects are amplified in challenging sports, such as sailing.

The Friends of the Guernsey Sailing Trust was formed in 1991 to allow individuals to assist the GST in raising valuable funding. The GST would not be able to provide the service it does without the generous support that it receives.
